It has certainly been a busy year and I am pleased to report on some recent activity highlights, in addition to wishing you all a very happy holiday and new year!

Category 3 Animal Fats protecting a vital ingredient

In 2022, FEDIAF has been focused more acutely on its sustainability activity. In addition to the 'normal work' within our Environmental Sustainability Working Group on packaging, sustainable use of ingredients and the update of the Product Environmental Footprint Category Rules (PEFCR), we identified a serious risk in the EC's activity to decarbonise transport: the possibility to include the use of Category 3 fats by-products as biofuels within the legislative process.

In order to explain why this is important for the pet food industry, we need to explain the role of Category 3 animal fats. Category 3 animal fats is a key raw materials for our pets' diets. They are essential fatty acids, which provide a source of energy and contribute to palatability. They cannot be easily replaced.

Decarbonization of transport has become one of the key pillars of EU Green Deal, something that FEDIAF — The European Pet Food Industry, representing 15 European national pet food associations, together with five pet food manufacturers operating in Europe — wholeheartedly supports.

Category 3 animal fats are also at the heart of our sustainable business model. Our practice is based on using these unwanted by-products from the human chain. By maximising the use of by-products and adding value, converting them into nutritious pet food, the industry is not competing with the human food chain and contributes to the circular economy.

Pet food sits well above energy use in the EU's own hierarchy of most-preferable options for food waste disposal. Additionally, impact assessment has shown that Category 3 animal by-products are not a necessary element for decarbonisation of transport (road, aviation nor maritime). There are alternatives such as Category 1 and 2 animal fats, which are not suitable for use in pet food, for safety reasons.

EU Code of Conduct



In January 2022 FEDIAF signed the Code of Conduct on responsible food business and marketing practices to show how Industry is committed to support the transition towards more sustainable food systems. FEDIAF is currently drafting its first annual report highlighting the numerous activities undertaken to disseminate and promote the Code in order to encourage more sustainable practices.

Activities range from promoting the Code at our Annual Congress and AGM, in the Annual Report, newsletters, LinkedIn, website, press releases and external presentations. Additionally, our Nutritional Guidelines are an excellent example of where FEDIAF supports the industry in providing detailed guidance. We also reported on our collaborations with stakeholders such as the Pet Alliance and our work with other stakeholders to protect Category 3 animal fats, which are vital for our industry and our sustainable practice.
